

Guide to Communicating Your Sylvera Rating

As the developer of a Rated carbon project, you may share your letter rating externally, provided that you comply with each of the following requirements at all times when sharing the rating:

- Prominently display the date of the rating
- Include a link to the Sylvera website, alongside the required blurb and disclaimer (see below)
- Do not state or imply that Sylvera's rating is an endorsement, certification or recommendation to invest in your project
- Do not share or display any detail from the report other than the letter rating, date and associated blurb and disclaimer
- If the rating is 'On-Watch' - this must be included in any material that references the Rating.

Any sharing of the rating outside of these guidelines is not permitted.

How to Communicate Your Rating

You may feature your Sylvera Letter Rating in presentations, brochures, social media and websites.

Ensure any mention includes the required rating blurb and links to Sylvera.

If you have a provisional rating then you must include the 'p', i.e. pBBB

Required Rating Blurb

All mentions of your Full Sylvera Rating must include the following statement:

We are pleased to announce that [Project Name] has been assigned a Sylvera Rating of [XXX] as of [DD/MM/YYYY]. [If On-Watch: Sylvera currently has this Rating On-Watch.] For information on how to see the live Sylvera rating, [please see here](#).

A Sylvera Rating assesses the likelihood that the claimed carbon impact of a project is a true representation of its real impact and is based on a combination of three core scoring pillars: Carbon Score, Additionality, and Permanence.

Provisional Ratings - Please use the below blurb in addition



A Provisional Rating, shown as, for example, pAAA-pD, is assigned where essential data is missing or incomplete. Provisional Ratings are issued based on the best available information, with reassessment possible when new data emerges.
